Timeline of Events



Updates from Task Force & Working Groups

Working Group on HPH and Health Literate Health Care Organizations

Led by the WHO Collaborating Centre for Health Promotion in Hospitals and Health Care (WHO-CC) at the Austrian Institute of Public Health in Vienna, Austria, an international working group was established within HPH to create a self-assessment instrument for evaluating organizational health literacy in hospitals and health literate organizations.

It is now accessible as the International Self-Assessment Tool for Organizational Health Literacy (Responsiveness) of Health Care Organizations (Hospitals). It features eight standards, each with sub-standards and operationalized by over 150 indicators.

The work of the HPH and Health Literate Health Care Organizations working group has been adopted by the WHO Action Network on Measuring Population and Organizational Health Literacy (M-POHL). Ongoing efforts involve translating, culturally adapting, and piloting the comprehensive OHL-Hos tool in various countries and healthcare contexts. National pilot findings will be analyzed to create an improved international version for benchmarking across regions and healthcare systems.

Task Force on Migration, Equity and Diversity

The Task Force underwent a renewal process during the 33rd of November 2023 General Assembly, where efforts were made to ensure its continued effectiveness and relevance. James Glover from Ireland and Hans Verrept from Belgium were elected to lead the Task Force, bringing fresh perspectives and leadership to the team. Subsequently, they presented a comprehensive plan outlining the strategic direction and objectives for the upcoming years, emphasising their commitment to steering the Task Force toward continued success and accomplishment of its goals.

Task Force on Children and Adolescents, led by Dr. Ilaria Simonelli

The task force has been actively implementing its plans; a webinar on 'Children's rights to play and participate in artistic activities in healthcare settings' scheduled for March 2024 featuring Red Noses was in planning stages in 2023, with the secretariat providing the platform and comprehensive support for the event.

Task Force on HPH and Age-Friendly Health Care, led by Dr. Shu-Ti Chiou

The Taskforce on Health Promoting Hospitals (HPH) & Age-Friendly Healthcare orchestrated a highly successful webinar titled "Integrating Age-friendly healthcare towards healthy ageing for all" in collaboration with the International Network of HPH, attracting a substantial audience with 159 registrations.



The task force pursues the following objectives:

Collect, select, and share knowledge for health promoting built environments (HPBE) through a public knowledge sharing platform and informational events.

Contribute to new partnerships across the design disciplines, expanding HPH's presence and familiarizing designers with the strategies and standards of HPH.

Assess and enhance HPH Standards to include built environment considerations. Involve more designers in the leadership of HPH and incorporate design education into the construction of HPH.

Inform healthcare organizations of the key connection between the built environment and health and support them in decisions to develop HPBEs LinkedIn page integrated with the HPH main page.



We took several steps this year towards realizing the goals outlined in the Global HPH Strategy 2021 – 2025:

New Members:

HPH experienced significant growth with the inclusion of new members from diverse regions. The expansion extended to Uganda, Latvia, and Panama, and a novel network was established in the United Arab Emirates.

Anticipating continued development, new Panama and the Campagna Region networks will become integral parts of HPH in the upcoming year.

The HPH eCommunity

In a strategic move towards enhanced collaboration and communication, the HPH eCommunity was officially launched during the 2nd Coordinators' meeting in March 2023. Coordinators were provided with access and detailed information on optimizing the platform, and initial feedback was collected. Looking ahead, HPH is committed to the continuous development of the eCommunity, with plans to enhance its user-friendliness in the coming months.

Research Publications – Policy Briefs

As an integral component of the strategic plan for the period 2021-2025, the Secretariat is actively engaged in the development of a series of policy briefs addressing significant topics. These briefs are slated for publication early next year. This initiative marks an exciting collaborative opportunity, as the Secretariat works in conjunction with the WHO Collaborating Centre and WHO EURO to contribute valuable insights to the discourse on pertinent issues.

Advocacy

Throughout the year, the International Health Promoting Hospitals (HPH) Secretariat actively participated in various conferences and seminars, showcasing its commitment to advancing health promotion initiatives.

Italian HPH Networks Standards Workshop

The Italian HPH networks hosted a national training webinar on April 20th, titled "Self-assessment tools of health promotion in the healthcare setting: Basic principles, standards, and indicators." Attended by 141 participants, the event featured an international session with contributions from esteemed speakers including Prof. Dr. Oliver Groene (International HPH Secretariat), Dr. Cristina Iniesta Blasco and Dr. Manel Santiñà Vila (Catalonia, Spain), Dr. Ilaria Simonelli (Leader of the HPH Task Force on Children & Adolescents), and Dr. Cristina Aguzzoli (Coordinator of the Italian HPH Networks). These experts provided valuable insights into the development and implementation of the 2020 HPH Standards.





French Symposium on Environment and Health Promotion

The French HPH Network, under the management of RESPADD (Réseau de prévention des addictions), actively supports its members and fosters an exchange platform through an annual symposium. This event, open to French HPH members and other health promotion professionals, received funding from the French Public Health National Agency and was moderated by Marianne Hochet, the Coordinator of the French HPH Network. Held in Lyon, this year's symposium focused on environmental health topics.

The event featured theoretical and practical plenary sessions, workshops, and an international session with presentations from distinguished figures such as Prof. Dr. Oliver Groene of the International HPH Secretariat, Elke Miedema PhD (Leader of the HPH Task Force on Built Environment), and Dr. Ming-Nan Lin (Leader of the HPH Task Force on Environment). These sessions inspired participants and facilitated engaging discussions on supporting the environment.

International Conference on Integrated Care, Antwerp, Belgium

At this year's 23rd International Conference on Integrated Care, Keriin Katsaros delivered a presentation in a parallel session focused on achieving improved health outcomes for all. The presentation, titled "Using the settings" approach to health promotion in hospital and health services to support collaboration, engagement, and partnership in integrated care systems," underscored the alignment of mutual values found in both the 2020 Health Promoting Hospitals (HPH) Standards and the nine pillars of integrated care. Katsaros illustrated how hospitals and health services can effectively implement HPH standards to foster a shared vision, facilitate multisectoral action, and encourage community participation in the pursuit of integrated care systems.





CleanMed Europe, Berlin, Germany

Health Care Without Harm's annual conference, CleanMed, unfolded this year in Berlin, Germany, on June 7th. Prof Dr Oliver Groene played a significant role as a judge representing the Health Promoting Hospitals (HPH) initiative in the evaluation of the European Sustainable Healthcare Project of the Year award.

This accolade acknowledged hospitals and healthcare providers throughout Europe who demonstrated outstanding efforts in implementing projects aimed at reducing the environmental footprint of their organizations. Oliver Groene's participation underscored the commitment of HPH to contribute to and recognize advancements in sustainable healthcare practices.

WHO Meeting in Baku

Oliver Groene was invited by WHO to attend a high-level meeting on hospital reform in the WHO European Region. In his presentation entitled "The role of health promotion to improve quality and sustainability of health care" he gave an overview on how health promotion can contribut to ongoing hospital reforms.



2nd Online coordinators Meeting, March 2023

In March, Coordinators, Task Force Leaders, and the International and Conference Secretariat convened for a strategic meeting to delineate actions for implementing the outstanding goals outlined in the Global Health Promoting Hospitals (HPH) Strategy for 2021– 2025. Participants from 11 countries provided valuable insights, sharing perspectives from their respective regions and reporting on the progress of HPH implementation within their areas. Additionally, during the meeting, the International HPH Secretariat unveiled the final prototype of the HPH eCommunity.

Governance Board Meeting in Hamburg, June 12-13, 2023

The International Network of Health Promoting Hospitals (HPH) annually convenes the Governance Board for a two-day meeting, and the latest session took place in Hamburg on the 12th and 13th of June 2023. The meeting encompassed discussions on several crucial topics, including the outcomes of the Coordinator's survey conducted in May. This survey, focusing on implementing HPH standards, not only shed light on areas for improvement but also formed the basis for deliberations on the Annual Fee structure. The discussion considered global inflation and the escalating costs associated with sustaining the services of the Secretariat.

Furthermore, the meeting served as a platform to gather initial feedback and the initial responses of the Governance Board to the recently launched eCommunity platform. Agenda Health Promotion

29th HPH Global Conference in Vienna, Austria

The 29th International Conference held in Vienna marked as the inaugural hybrid conference, following a year without a conference. Extending over three and a half days, the conference encompassed a rich program and facilitated extensive networking opportunities. Additionally, registered participants were granted on-demand access for post-viewing for at least two additional months.

The program featured five plenary sessions that brought together 19 distinguished international speakers and panellists from various parts of the world. Notably, the fifth plenary session, chaired by Prof. Dr Oliver Gröne, CEO of Health Promoting Hospitals (HPH), included Ilona Kickbusch among the four panellists.

An impressive response was received, with over 670 abstracts submitted and reviewed, originating from 27 countries (Asia 89%, Europe 10%, 2 from the US, and 1 from Africa). Out of these, 405 abstracts (60%) were accepted for presentation, contributing to 23 Oral sessions and 11 mini-Oral sessions, as well as forming a virtual poster gallery, showcasing a diverse range of contributions from the global healthcare community.

Conference Dinner

The conference dinner, accompanied by live music from Solidtunes was organized by the Conference Secretariat and held at the Rittersaal of the Rathskeller, Vienna; served as a distinctive social event, offering participants a unique opportunity to network and partake in a memorable evening in the picturesque city of Vienna.















HPH Coordinators Meeting

The Coordinators Meeting convened on September 20, 2023, brought together coordinators, representing 14 national and regional Health Promoting Hospitals (HPH) networks.

The primary focus of the meeting was collaborative engagement and discussions surrounding the various activities undertaken within their respective networks.

Dr. Yuuki, representing Nishi-Yodo Hospital in Japan, delivered a presentation highlighting their innovative health promotion initiatives, providing valuable insights and fostering knowledge exchange among the coordinators.





An interactive exercise was introduced during the meeting to enhance collaboration within the network. Coordinators actively participated in identifying three strengths (,haves') and three areas for improvement or value addition (,wants') within their country's HPH network. This exercise aimed at promoting constructive dialogue and facilitating a collective effort to strengthen further and refine the capabilities of the HPH networks.

GB Meeting, 20th September 2023

Taking advantage of the opportunity presented by their presence in Vienna, the Coordinator's meeting was succeeded by a concise Governance Board Meeting. During this session, several crucial topics were deliberated upon, including the prospective renewal of the Task Force on Migration, Equity, and Diversity. Additionally, discussions were initiated on establishing a new task force centred around the Relationship between Culture and Health. The formal approval for these initiatives is slated to occur during the 34th General Assembly meeting in 2024.

Furthermore, the meeting addressed the election process, with board members actively engaging in the identification of suitable nominations for the two vacant seats on the Governance Board. The formal elections for these positions were scheduled to transpire later during the 33rd General Assembly meeting.



Meeting of the Scientific Committee of the 29th International HPH Conference

The primary responsibilities of the Scientific Committee include guiding the general structure, scope, purpose, title, topics, and selection of plenary speakers for the conference. Furthermore, it supports the abstract review and selection process for parallel oral and poster sessions.

As outlined in the HPH constitution, the Scientific Committee serves as a representative body comprising all members of the Governance Board, representatives of the local host of the conference, volunteers sourced from National/Regional HPH Networks, HPH Task Forces, and Working Groups, as well as individual HPH members. It also includes conference co-organiser representatives and external scientific and clinical experts.

The chair of the Scientific Committee represents the International Conference Secretariat, and the co-chair is a nominee from the local host.

A broader Scientific Committee is formed to ensure comprehensive feedback on the conference program and assist in abstract screening and promotion. This committee contributes to refining the conference agenda and enhancing its overall quality.

A smaller group known as the Scientific Executive Board convenes for final discussions and decisions. This board meets three times during the development of the conference program each year, contributing to the meticulous planning and successful execution of the International HPH Conference.

Declaration Sigining Ceremonies and Partnership collaborations Global Network for Tobacco free Healthcare Services (GNTH)

On September 20th, a momentous joint declaration was formalized between Health Promotion Hospitals (HPH) and the Global Network for Tobacco-Free Healthcare Services (GNTH). The declaration was officially signed by Bożena Walewska-Zielecka, Chair of HPH, and Susann Koalick, Chair of GNTH.

The GNTH/HPH Declaration specifically addresses electronic nicotine delivery systems (ENDS), electronic non-nicotine delivery systems (ENNDS), Heated Tobacco Products (HTPs), and nonmedical nicotine products. This significant agreement represents a major step towards a nicotine-free future within global healthcare settings, underlining the crucial need to protect patients, staff, and visitors from the detrimental effects of nicotine in various forms.

This initiative plays a pivotal role in cultivating a healthier environment within healthcare facilities and society.

Furthermore, the alliance between HPH and the WHO Action Network on Measuring Population and Organizational Health Literacy (M-POHL) holds immense potential. M-POHL, as a WHO Action Network, specializes in measuring and enhancing health literacy at both individual and organizational levels. Through international surveys and data collection on organizational health literacy, M-POHL provides invaluable insights into the healthcare landscape. Their work aligns seamlessly with WHO's policy frameworks, contributing to evidence-based decision-making and shedding light on health literacy on a global scale.

This collaboration between HPH and M-POHL is poised to significantly strengthen health literacy, elevate healthcare quality, prioritize patient-centered approaches, and foster overall well-being. The agreement was formally sealed through the signatures of Prof. Dr. Oliver Groene, PhD (CEO, International HPH Secretariat), Bożena Walewska-Zielecka (Chair, International HPH Network), Christina Dietscher, and Diane Levin-Zamir (M-POHL Co-chairs). The signing ceremony took place in the presence of Christa Straßmayr (Coordinator of the ICC of M-POHL) alongside Birgit Metzler, Peter Nowak, Giulio Fornero, and Shu Ti Chiou.



33rd meeting GA, November 22nd 2023

The 33rd General Assembly Meeting, held on November 22nd, 2023, featured significant updates and key activities. The session commenced with a comprehensive report on the Governance Board's activities throughout 2023, providing insights into the network's strategic initiatives. Additionally, the meeting included a presentation by the external auditor and the HPH Treasurer's Report, detailing the income and expenditures of the network for the year 2022. An essential agenda item involved the Governance Board Elections, shaping the leadership for the upcoming term.

Task Forces within the HPH Network were a focal point, with Shu-Ti Chiou presenting and renewing the Task Force on Health Promoting Hospitals (TF-HPH) and Age-Friendly Healthcare, while James Glover and Hans Verrept addressed the renewal of the Task Force on Migration, Equity, and Diversity. Giulio Fornero presented the newly formed Task Force on the Relationship between Culture and Health, reflecting the network's commitment to diverse and inclusive healthcare approaches.

The General Assembly also heard insightful presentations from distinguished representatives, including Szörényiné Ványi of Moritz Kaposi General Hospital in Hungary, Mitsuhiko Funakoshi of the Japan HPH Network, and Murad Al Badar Tardi and Taif Al Sarraj of the UAE HPH Network.

A significant decision was reached during the meeting, with members approving a 10% increment in the annual HPH membership fee from 2024 onwards. This measure aims to ensure the sustainability of the network's activities and continued advancement in promoting health across diverse healthcare settings.

Prof Dr Oliver Groene presented, on behalf of HPH treasurer Dr. Sally Fawkes, an overview of accounts at the November meeting of the 33rd HPH General Assembly.

Income

Total income for the year 2022 was 137.863€.

The primary source of this income comes from HPH membership fees from National and Regional HPH networks and single members.

Expenditure

Total expenditure for the year 2022 was 143.633€.

The Secretariat costs totaled 133.272€ in 2022. The remaining direct and indirect costs were 4.198€ for platform hosting/media design, 3.612€ for travel, 703€ for incidental expenses, and 1.849€ for tax certificates and legal fees.
