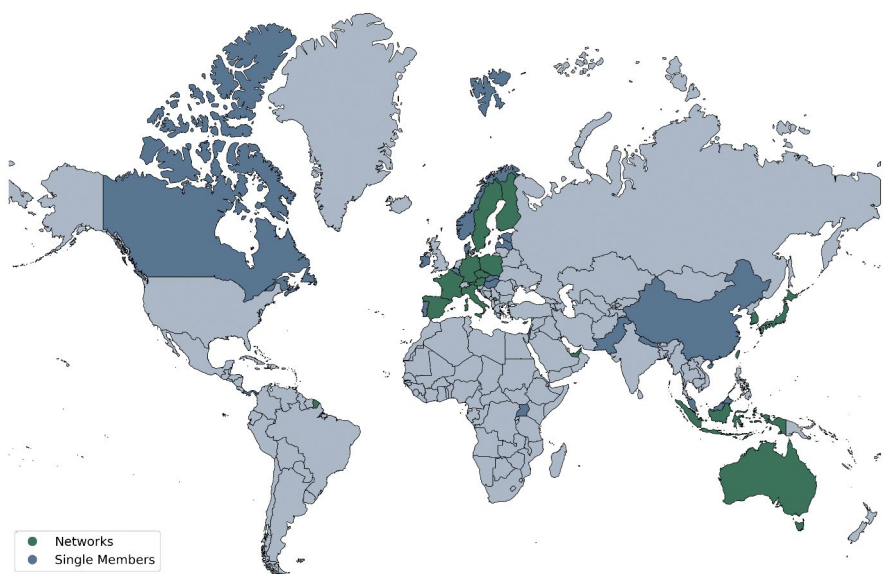

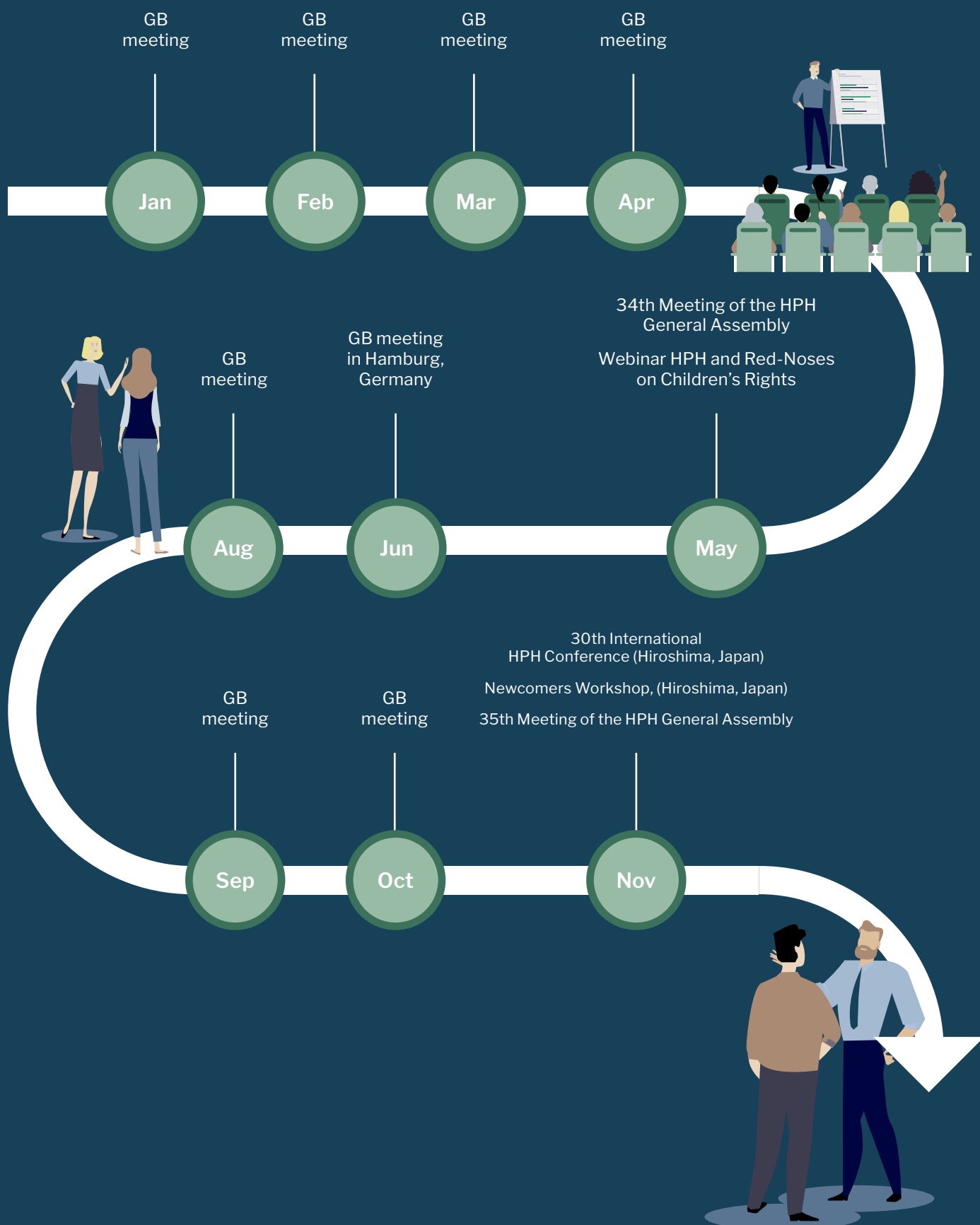

Year 2024 in Review:

Key Highlights from the International HPH Secretariat

The International HPH Secretariat has made significant strides in advancing the Global HPH Strategy 2021–2025, implementing a variety of strategic initiatives throughout the year. Here are some of the key highlights:

Membership Growth

As of November 2024, HPH's membership has reached 568 members. This year, we proudly welcomed several new additions to our National French, Japanese, and Hong Kong HPH Networks. Moreover, the Värmland region of Sweden has rejoined our network.

We also welcomed individual members from existing countries such as Israel, as well as from new countries including Nepal, Belgium, Ireland, and the Islamic Republic of Iran. Notably, three new members from Kosovo and the Campania region of Italy facilitated the establishment of two new networks: the HPH Campania Network and the Kosovo HPH Network.

Formation of the Future Leaders Advisory Board

In alignment with Goal #3 of the current HPH Global Strategy, we launched the Future Leaders Advisory Board in 2024. This board consists of eight outstanding members who will play a crucial role in supporting the processes and functions of our networks. Further details can be found later in this report.

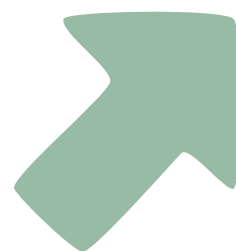
Social Media

The HPH eCommunity

HPH is dedicated to continuously improving the eCommunity to enhance its user experience and fulfill its original purpose. The previous platform, launched in March 2023, did not meet our expectations due to a challenging registration process, an unintuitive interface, and high operational costs. As a result, the Secretariat is upgrading the service platform to a new platform, due to be launched in early 2025.

Future Leaders Advisory Board

Under the Global HPH Strategy for 2021-2025, we are committed to achieving goal number three: „Cultivating the Next Generation of HPH Leadership.“ In July 2024, we established the HPH Future Leaders Advisory Board to ensure the long-term vitality and impact of the HPH network. Through this initiative, we are not only investing in the leaders of tomorrow but also ensuring that the HPH network remains dynamic, innovative, and responsive to the needs of its members. This also recognizes the vital role that young professionals play in shaping our future and provides a dedicated platform for their insights and contributions.

Chair: Dr Giuseppe Melcore, MD/MSc (Italy); Chair

Giuseppe is currently a resident in Occupational Health at the Università Cattolica del Sacro Cuore, stationed at the Ospedale Policlinico Gemelli. Additionally, he collaborates with the renowned Ospedale Pediatrico Bambino Gesù in Rome. He holds a master's degree in healthcare management and risk management. Driven by a profound passion for mental health, he is now pursuing a master's degree in clinical and forensic Psychodiagnostics. His professional endeavors and research are centered on workplace well-being, prevention, safety and health promotion.



Vice Chair: Dr Elisabeth Nöhammer, Associate Prof. (Austria); Vice Chair

Elisabeth has a background in management, socio-economics (both Masters) and health sciences (Doctorate), which she combines in her research and teaching as an Associate Professor at UMIT TIROL, Austria. He graduated from medical school in Paris and Lyon and from the Europubhealth+ double master in Granada (Spain) and Maastricht (the Netherlands), with a specialisation in Governance and Leadership in European Public Health. He has clinical experience and a professional tropism in STI/HIV prevention, family planning, vaccination, and student health.

Usman is an Adjunct Associate Professor at the University of New South Wales, Australia, with extensive experience in pharmacy, healthcare management, and health informatics. Formerly an Associate Professor and Digital Health Consultant at Taipei Medical University, he is recognised as a Fellow of prestigious societies such as the International Society for Quality in Health Care and the International Association of Health Informatics and Sciences. He has co-edited journals and spearheaded international Digital Health projects with institutions like Harvard-Massachusetts Institute of Technology. His research, encompassing Digital Health, Artificial Intelligence in medicine, Global Health Informatics, Telemedicine, and Healthcare Quality Management, reflected in over 180 publications.

Ana is passionate for inspiring people for scientific education and works for a more effective healthcare system. In addition to her position as a Partner from PEV, she serves as a Professor of Epidemiology at UFRGS, HCPA, and Insper and as a Senior Researcher in Health Policy and Economics. Ana has a Ph.D. in industrial engineering at UFRGS, in collaboration with Stanford, and completed her post-doctoral fellowship in epidemiology at UFRGS in partnership with Brigham Women's Hospital. She also attended the VBHC Seminary at Harvard Business School and is certified in Effective Writing for Health Care by the Harvard Medical School. She has penned more than 140 publications, all focusing on the intricate fields of Health Economics and Value-based Care.



Member: Sabrina Fournier (France)



Sabrina is a research engineer at the consortium (half hospital, half university) Evidans of Bordeaux. The projects she leads and coordinates are designed to develop « preventive clinical practices », set up structured health channels accessible to prevention, and adapt the MECC (Make Every Contact Count) approach and methodology in the French context. She is also involved in university teaching (sanitary service for health students, final dissertation for advanced practice nurses) and engaged in French “reserve sanitaire,” which is a step in renfort when exceptional sanitary emergencies occur to strengthen the teams in place.

Member: Joanna Wargalla, MA MPH (Poland)

Joanna is a healthcare professional with a linguistic background. She has been working with the HPH Network since 2021. She has translated documents for the Polish HPH National Network and worked on assessing the implementation of HPH standards at a Warsaw hospital, CSK MSWiA. For the past three years, she has worked in the prevention and promotion department of a hospital-based medical institute, PIM MSWiA. Monika has been involved in the hospital's HPH program since 2014. She participated in several HPH conferences and presented the program at several nursing conferences. The Military University Hospital in Prague develops and implements health support projects for its patients and employees, enabling them to take better control of their health and improve it.



HPH Task Forces

Yearly Updates

1. Task Force on Migration, Equity and Diversity, James Glover and Hans Verrept

The MED-TF implemented the Year 1 actions in its Action Plan as approved by the HPH Network. This work involved revising and updating the Standards for Equity in Healthcare at a hybrid workshop held in Dublin, Ireland, in March 2024. The new Standards were approved by the MED-TF and presented at the 30th International HPH Conference in Hiroshima in November 2024. The MED-TF is proceeding with recruiting healthcare organizations to use the Standards during 2025 and looks forward to reporting back to the HPH at the end of 2025 with Phase 1 results.

2. Task Force on Children and Adolescents, Dr. Ilaria Simonelli

In 2024, the Task Force Coordinator demonstrated significant contributions across several key initiatives. These included leading the successful implementation of the EU Project COPE, which provided health promotion interventions to nearly 1000 NEETs in Italy. This involved close collaboration with the Healthcare of Trento and other European partners. Furthermore, the Coordinator co-authored a crucial Position Paper on the Right to Play for Hospitalized Children, a joint effort with Red Noses International and Culture Action Europe. This work was further complemented by the organization of a successful webinar on

Children's Right to Play, conducted in collaboration with Red Noses International, raising awareness on the vital role of play in child development.

3. Task Force on HPH and Age-Friendly Health Care, Dr. Shu-Ti Chiou

The Task Force on HPH and Age-Friendly Health Care (TF-AFHC) actively pursued its strategic objectives within the International HPH Network, aligned with the UN Decade of Healthy Ageing's Plan of Action 2021-2030. In advocacy and partnerships, the TF-AFHC headquarters in Taiwan demonstrated the impact of Age-Friendly Health Care on national policy development by supporting the Taiwanese Parliamentary Commission on Strong-Generation Policies and Economic Development in their legislative efforts to combat ageism and foster enabling environments for healthy ageing. At the international level, the TF-AFHC partnered with an NGO to plan the satellite event „Application & Development of AI-enabled Solutions in Care Industry“ at the 2025 UN NGO CSW69 Forum. Furthermore, the Chair attended the 2024 European Health Forum Gastein, themed „Shifting sands of health-democracy, demographics, digitalisation,“ to promote the concept and activities of the TF-AFHC. In capacity building, the TF-AFHC organized a Symposium on HPH & Age-friendly Health Care in Hiroshima, Japan, titled „Contribution of Age-friendly Hospitals & Health Services to Health Equity- Experiences from East and West,“ attracting approximately 40 participants. In Taiwan, where most of its members reside, the TF-AFHC conducted a „Global Health Elites Training Camp on NCD prevention & control and healthy ageing under the 2030 Sustainable Development Agenda,“ engaging 40 participants. In cultivating next-generation leadership, the Health and Sustainable Development Foundation, a

supporting organization of the TF-AFHC, sponsored three recipients of the Global Health Elites Scholarship Program to attend the 2024 European Health Forum Gastein, September 24-27, 2024.

4. Taskforce on Health Promoting Built Environment, Elke Miedema and Peyton Fort



The Health Promoting Built Environment (HPBE) Taskforce experienced a productive year in 2024, advancing its mission to collect, select, and share knowledge about building design for health-promoting healing environments and communities. Aligning with its objectives, the taskforce expanded its membership to twelve active members across thirteen countries in North America, Europe, Asia, and Australia, fostering diverse new partnerships within the design disciplines and expanding the network's reach. To support healthcare organizations in evidence-based decision-making, the taskforce collaborated

with other HPH task forces and external partners like the Red Noses Foundation to conduct webinars. Knowledge exchange was further facilitated through the HPBE's LinkedIn page and key initiatives, including the development of a webpage featuring references to national evidence-based design knowledge centers, the publication of research on enablers and barriers of health-promoting built environments, and the creation of foundational materials for upcoming webinar series and an eLearning database for healthcare leaders and architectural designers.

The taskforce demonstrated its commitment to knowledge dissemination through active participation in several global conferences. At



the ARCH24 conference in Helsinki, Finland, with its focus on 'effects of design on health and wellbeing,' members contributed posters and presentations. At the 2024 International HPH conference in Hiroshima, Japan, HPBE members conducted a workshop on Health Promoting Built Environment and Design for Equity and Empathy, hosted a roundtable on 'Barriers and Enablers for Recruitment Efforts,' and led a parallel session on Healing Architecture.

The HPBE Taskforce eagerly anticipates continued growth and contributions in 2025, further advancing the integration of health-promoting design principles in the development of inclusive healing environments

5. Task Force on Well-being of Healthcare Workers Task Force, Dr. Cristina Aguzzoli, Dr. Jaekyung Lee and Gabriella Szörényiné Ványi

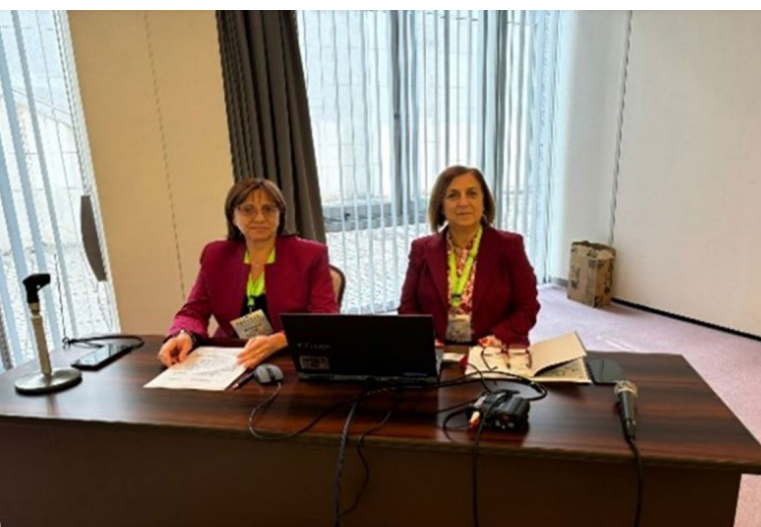
The Task Force Coordinator welcomed two new members: Maria Linderström from Sweden and Amelia Ceci from Italy. The coordinator prepared the questionnaires necessary for collecting good practices related to health promotion and well-being of health workers. At the 30th HPH Congress held from November 6-8, the Task Force presented its objectives and introduced the online questionnaire for collecting good practices to Congress attendees. Following the Congress, the online questionnaire was uploaded to the HPH Network website and subsequently emailed to all participants who had presented on health promotion and well-being of health workers. The second phase of the survey involves a more detailed questionnaire for in-depth analysis of their good practices.



6. Task Force on Culture and Health, Alda Cosola

On the 30th International Conference of the Network HPH Network held in Hiroshima (Japan), the HPH Network Piedmont proudly unveiled the new Task Force „Health and Cultures“. In today's world, the significance of culture and the arts in the care relationship, for prevention purposes, and for health promotion is extensively supported by a growing body of evidence from both science and the humanities. This foundation element is now integral to European and national policies actively working towards its integration into national plans and programs across various sectors of society. HPH (Health Promotion Hospitals and Health Services) is the international network embracing this challenge to innovate and reinforce organizational culture in managing care processes.

The relevance of health and culture became prominent in the healthcare system during the COVID-19 pandemic that began in February 2020. Health services were tested like never before, facing the challenge of social and physical distancing in emergency hospitalization and chronic disease treatment. During this period, the arts, in its broadest sense, demonstrated a therapeutic effect in maintaining and constructing the care relationship.



The Two Days of Study

In 2024, the HPH&HS regional network of the Piedmont Region provided an opportunity for in-depth study and constructive discussion on the human dimension in care relationships through an approach aiming to achieve health promotion via arts. On 4 and 5 June, two study days titled „La Cultura come risorsa per la salute – l'altra dimensione della cura“ were organized in Turin in collaboration with public and private institutions committed to promoting research and skill development on this issue.

Participating institutions and individuals included: HPH International: Oliver Gröne, Ilaria Simonelli, Ralph Harlid Culture Action Europe: Kornelia Kiss, Italian HPH Networks: Alda Cosola, Cristina Aguzzoli, Ilaria Simonelli, Elisabetta Confaloni, Amelia Ceci, University of Turin, ISS - Istituto Superiore di Sanità, DoRS - Documentation Center for Health Promotion of the Piedmont Region, CCW – Cultural Welfare Center, Medicina a Misura di Donna and Compagnia di San Paolo Foundation.

These study days showcased the growing body of evidence and scientific insights underscoring the importance of culture and the arts for well-being, emphasizing the need to rethink the organization of health services to enhance an arts-oriented health promotion approach.

Study Day 1, Workshop, 4 June 2025 –

During the study days, a panel was dedicated to presenting project experiences from hospitals and health services within the HPH network that experimented with artistic practices. These projects aimed to build empowerment relationships and alliances to commit to the health and well-being of patients, caregivers, and operators in various care contexts.

The projects were analysed using a survey form that cross-referenced data to picture the

characteristics of health and cultural projects. Analysis tools included: HPH Global Strategy 2021-2025, New Haven Recommendation and Standards for Health-Promoting Hospitals and Health Services 2020.

These tools were used in relation to the WHO Regional Office for Europe's synthesis report 67/2019, „What is the evidence on the role of the arts in improving health and well-being? A scoping review.“ This report defined engagement with the arts across five broad categories:

- › Performing arts (e.g., music, dance, theater, singing, film)
- › Visual arts, design, and crafts (e.g., painting, photography, sculpture, textiles)
- › Literature (e.g., writing, reading, literary festivals)
- › Culture (e.g., museums, galleries, art exhibitions, concerts, community events, festivals)
- › Online, digital, and electronic arts (e.g., animations, film-making, computer graphics)

Several sub-themes in health promotion were identified:

1. How the arts influence social determinants of health (e.g., social cohesion, social inequalities).
2. How the arts support child development (e.g., mother-child bonding, speech and language acquisition, educational attainment).
3. How the arts encourage health-promoting behaviors (e.g., promoting a healthy lifestyle, reducing stigma, engaging marginalized groups).
4. How the arts help prevent ill health (e.g., enhancing well-being, reducing trauma impact, lowering cognitive decline risk).
5. How the arts support caregiving (e.g., understanding health, supporting carers' well-being).

The survey results were summarized in a SWOT analysis, forming the basis for defining the objectives of the HPH Taskforce on Health and Culture.

Study Day 2: On 5 June, the study day held at the University of Turin – Cavallerizza Reale featured three panels: From Scientific Evidence to Policies, Culture as a Resource in the Health Promotion Plan and Health & Culture, an International Project of the HPH Network of Piedmont.



Webinar: HPH and Red Noses

Children's rights to play and participate in artistic activities in healthcare settings, 05 March 2024

RED NOSES International and the Task Force on Children and Adolescents of the International Network of Health Promoting Hospitals were excited to host a webinar on the promotion of children's health in healthcare settings. The event explored the significant role of arts in enhancing well-being and realizing children's rights, such as the right to play, leisure, and participation in artistic activities.

Background: Hospitals can be stressful for children, disrupting their routines and causing anxiety. The webinar delved into how arts and creative activities, particularly Healthcare Clowning, have evolved to positively impact the mental health of hospitalized children. The session aimed to raise awareness among professionals and policymakers, advocating for the implementation of Health Promotion Standards by the International HPH Network.

Expected Impact: The discussion centered around providing children with artistic activities in hospitals to enhance their mental health and well-being. The event emphasized the importance of policies that prioritize children's rights to leisure, play, and participation in cultural and artistic life. Participants joined the movement to make a positive impact on the hospital experience for children.

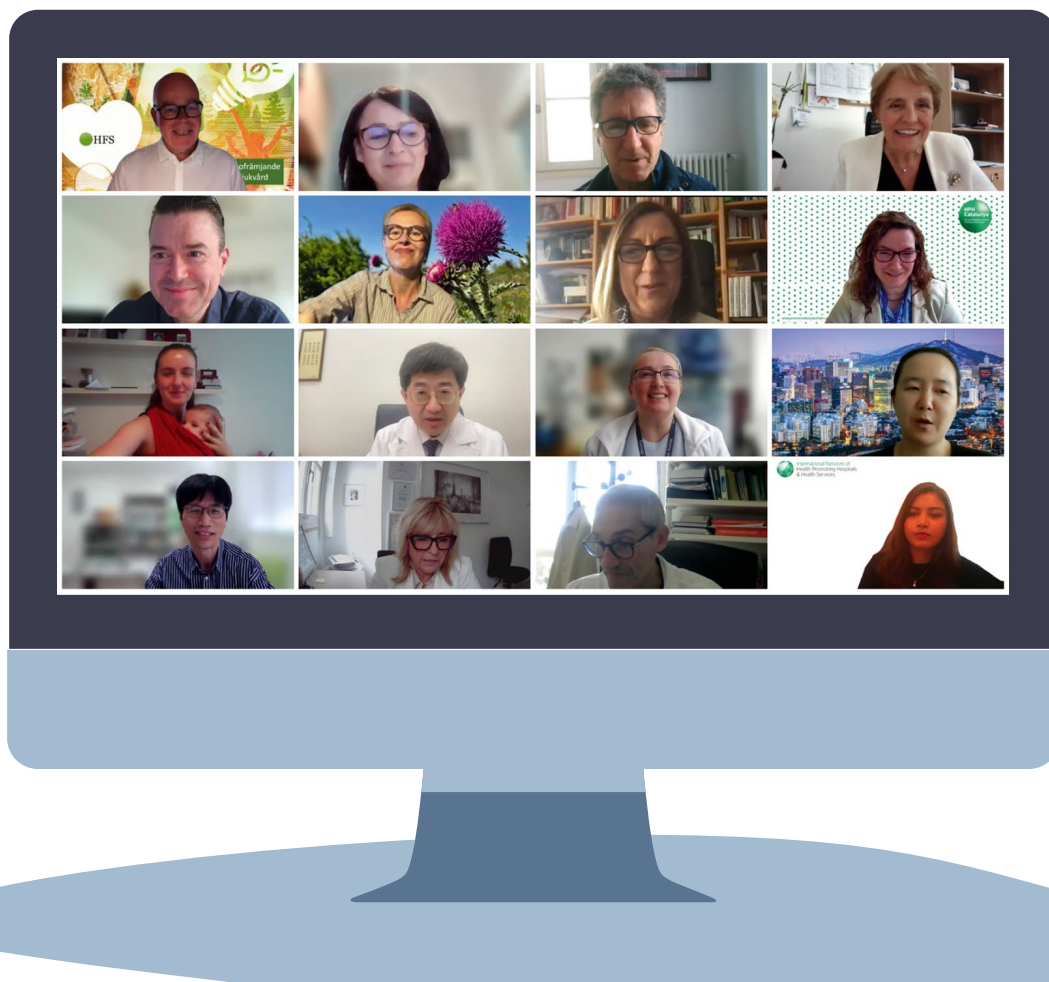

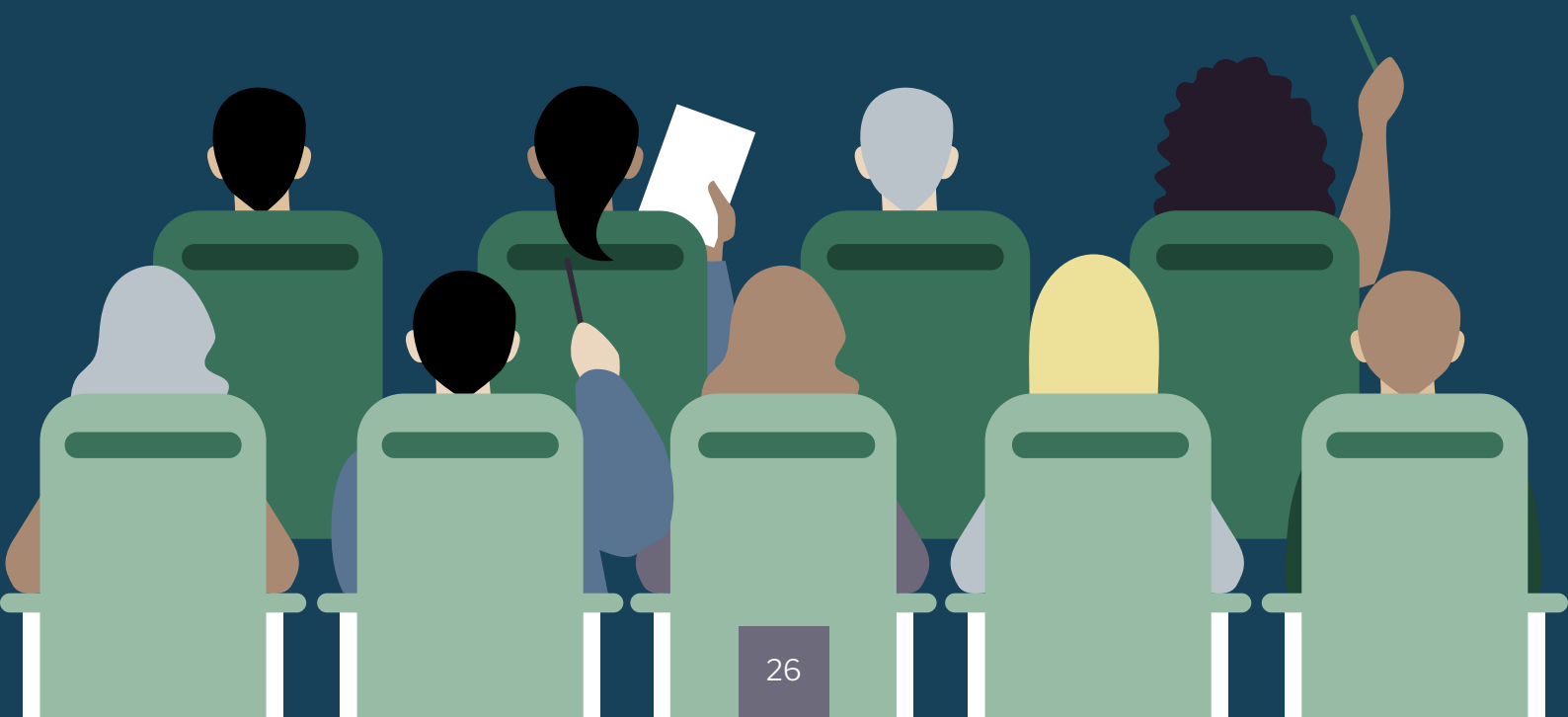

The 30th HPH Global Conference in Hiroshima, Japan

The 30th International Conference on Health Promoting Hospitals and Health Services was held from November 6-8, 2024, at the International Conference Center in Hiroshima, Japan. This year's theme, „The Contribution of Health Promoting Hospitals and Health Services to Health Equity,“ attracted nearly 800 participants from around the world. The event featured a diverse array of plenary sessions, oral presentations, and discussions addressing critical issues in health promotion.



The conference was significantly supported by the International Secretariat in Hamburg, which organized workshops for members, hosted the Governance Board Meeting, and facilitated both oral and plenary sessions. Prof. Dr. Oliver Gröne, CEO of the HPH Network, led a plenary discussion titled „The Role of HPH Networks in Promoting Equity Beyond the Health Sector.“ During this session, participants shared exemplary care models

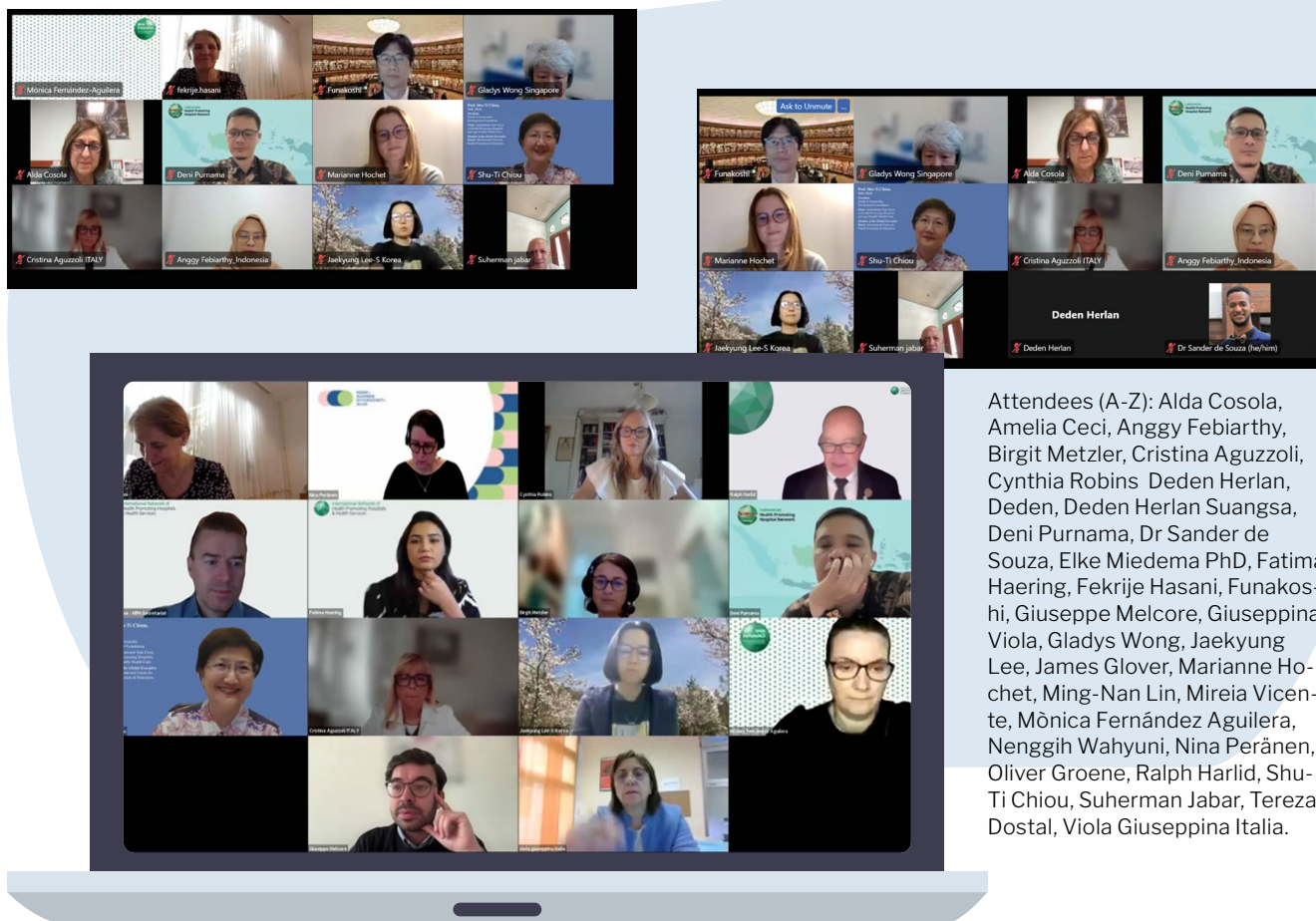

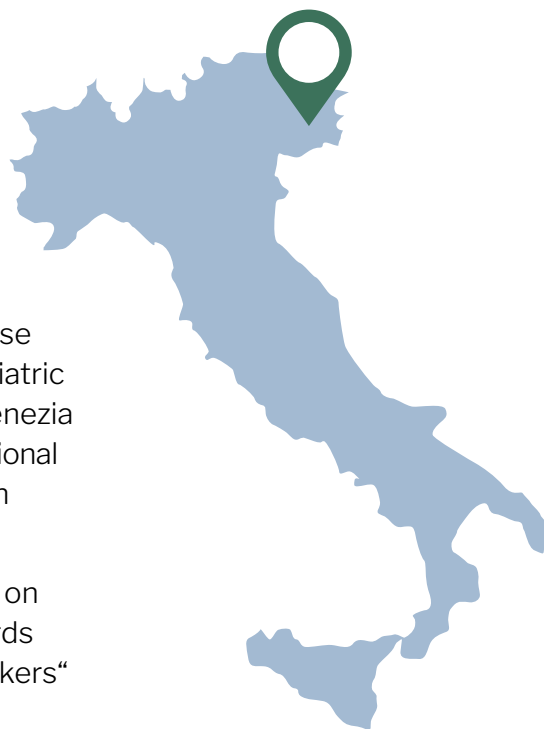
Advocacy

Conference: Promoting Health in Hospitals and Health Services – Change Comes from Within the System, 18 June 2024, Italy

The event was organized by the National Center for Disease Prevention and Health Promotion, IRCCS Child Jesus Pediatric Hospital, Regional Health Coordination Company, Friuli Venezia Giulia Region, Coordination of Italian Networks, and International Network Health Promoting Hospitals & Health Services, in collaboration with Local Health Authority of Rome 1

Prof. Dr. Oliver Gröne participated online, delivering a talk on „Health Promoting Hospitals and Health Services Standards and their Application for the Wellbeing of Healthcare Workers“ during the first session.



National Conference of Hungarian Hospital Association (HHA), May 8-10, 2024, Hungary

During the national conference in Mátraháza, nearly 1000 attendees participated. On the morning of May 10, Prof. Dr. Oliver Gröne gave a 20-minute plenary session presentation on the concepts, values, strategies, and standards or indicators of health promotion in the organizational structure and culture of hospitals and health services.



Study Visit to Budapest, Hungary within the Framework of the Health Promoting Hospital Network with the Kosovo Delegation, 10-14 September 2024

The study visit was facilitated by OptiMedis under the leadership of Prof. Dr. Oliver Gröne and Dr. Zsuzsa Rákossy-Vokó, the Head of Health Promotion at the Bethesda Children's Hospital in Hungary. They contributed to organizing and supporting the visit and hosting the Kosovo delegation. The visit aimed to gain insights into Hungary's national hospital health promotion program, foster collaboration between Kosovo and Hungarian health institutions, and develop practical skills and strategies for implementing similar initiatives in Kosovo.



Financial Report 2023

The audit report 2023 was assessed and approved by the HPH treasurer Dr Sally Fawkes and presented to the General Assembly during the 35th General Assembly Meeting in November 2024.

Income

Total income for the year 2023 was 137,863€.

The income was lower in the year 2023 because of the delayed payments of certain invoices, which were paid largely during the first quarter of 2024 and are not reflected in the financial account of 2023.

The primary source of this income comes from HPH membership fees from National and Regional HPH networks and single members.

Expenditure

Total expenditure for the year 2023 was 143,633€.

The expenditure includes various costs such as Personnel costs (Coordination, Partnerships and education, Management, Accounting, Communications, Web and social media platforms and Assistance). Other costs include Tax Certificates, legal fees, travel costs and Platform hosting/ Media design.
